

The Importance of the Nobel

This is the opportunity to disabuse ourselves of the CoViD vaccine falsehoods that are inherent in Phillip's alternative, conspiracy driven science:

Canberra Daily: the TGA rejects Altman report: ***"(Dr. Altman's) presentation contained many remarkable scientific errors of fact and significant misinterpretations about the safety of COVID-19 vaccines."***

In other words: ***"Dr. Phillip Altman's presentation was a travesty, I couldn't listen to his diatribe any longer."***

Phillip Altman: ***"Advice from the FDA, TGA etc is now worthless. After almost 4 years of constant lies, misinformation and disinformation, drug regulators around the world have failed miserably, nothing they have said is true."***

The question is: Does the above statement have any merit? No.

Does the 2023 Nobel Prize for excellence in Physiology or Medicine have any importance? Oh yes, it does ... it was awarded for: ***the development of effective mRNA vaccines ... dramatically contradicting, indeed negating Phillip's work ... the gist of which is that the mRNA vaccines don't work ... worse, they actually kill people.***

However, Phillips makes a point at rejecting the Nobel Prize - why? ***Extraordinarily***, because it was given to Al Gore for his work on alerting the world to Climate Change ... Phillip doesn't believe in CC ... apparently it's natural; yeah, true, with temperature changes of 7 degrees over 100,000 years, i.e. 1 degree every 14,000 years; man-made CC has risen the global temperature by 1 degree in 100 years.

Also, Barak Obama was given a Nobel Prize for his efforts to strengthen international diplomacy and cooperation between peoples, and his promotion of nuclear nonproliferation and a "new climate" in international relations, especially in reaching out to the Muslim world. Phillip neither likes Barak Obama nor Al Gore, ergo the Nobel Prize amounts to nothing ... ***O.M.G.*** This is preposterous, indeed childish.

One has to ask, are the Therapeutic Goods Administration (TGA) in Australia; the Centers for Disease Control (CDC) in America; the World Health Organization (WHO); the European Medical Device Single Audit Program (MDSAP); Health Canada etc. and the hundreds and thousands of scientists and health professionals in the fields of immunology and epidemiology that report to them, are they all wrong ... in fact, have they all been lying to the public about CoViD?

If anyone has even just the slightest inkling that this may not be the truth (how would this work, anyway?) ... then any trust in Phillip's advice needs to be reconsidered ...

... because, the point is: Phillip denounces the authorities; however, the information he proffers is from dubious, conspiracy laden sources. Just check the sources of his "information" - ***openVAERS.com*** (see the Wikipedia entry at the bottom of the next page) In fact, Phillip disingenuously (if not fraudulently) claims his data is from the CDC, while a closer look reveals the source to be OpenVAERS - and look at the forum where he publishes his interviews - Rumble ... a conspiracy driven platform.

"I searched for his credentials on the Internet, only to find his voice is found on conspiracy websites only ..."

At a function on Balmoral Beach one of Phillip's associates presented a list of about two dozen supporters, all medical professionals. My experience is (I didn't check the list) that his supporters from the medical fraternity (all most likely excellent in their fields) typically are cardiologists, pharmacologists, dentists, gastroenterologists ... with an *opinion* on CoViD. The TGA, the CDC, the WHO etc get their advice from - not dozens, not hundreds, but presumably thousands ... immunologists, epidemiologists and virologists.

Phillip says they are being censored; which is patently not true. In fact he doesn't know what censorship is: if in Russia you criticise the government and say the Ukraine war is wrong, you go to a Gulag in Siberia where you'll be killed; if in China you say thousands were killed in the Tiananmen square massacre, you go to a re-education camp, most likely never to emerge again; you're sent to jail in Germany if you publically deny the Holocaust, that 6 million Jews were killed by the Nazis ... that's censorship at work.

But Phillip has his substack where he can shout out to the world to his heart's content ... nobody censors him. However, his work doesn't get published because: ***"The report was self-published without peer review, so was not credible and had not been through the scrutiny required for publication in a reputable scientific journal."*** TGA. The point here is: I have repeatedly asked for proof - even just mention in a reputable publication of his claim of 30,000 (apparently risen to 60,000) deaths due to CoViD vaccinations - to no avail.

Phillip has a bigger problem than censorship ... ignominy ... he's wrong, and thus is being ignored by the mainstream medical fraternity. That Phillip and his associates don't accept the accuracy and validity of the work carried out by the world's health authorities puts him - and them - firmly into the group of conspiracists ... the same people who deny CC and that Donald Trump lost the 2020 election.

A WARM WELCOME: Dr John Campbell is coming to Australia. All-star speakers gather for one day in Sydney including professors Robert Clancy and Gigi Foster, Dr Melissa McCann and Dr Phillip Altman.

It will be “a warm welcome to this talk” in April when the internet’s best-loved medic Dr John Campbell comes to Australia.

Speaking at Double Bay’s Golden Sheaf hotel on Wednesday, Professor Gigi Foster said the ASF was also in the process of organising for Dr Campbell to speak at University New South Wales on Easter Monday, April 1.

It’s interesting to check the bona fide of the people involved ... all of them known spreaders of misinformation (Wikipedia):

John Lorimer Campbell is an English YouTuber and retired nurse educator known for his videos about the COVID-19 pandemic. Initially, the videos received praise, but they later veered into **misinformation**. He has been criticised for suggesting COVID-19 deaths have been over-counted, repeating false claims about the use of ivermectin as a COVID-19 treatment, and providing misleading commentary about the safety of COVID-19 vaccines.

Robert Llewellyn Clancy AM is a retired Australian clinical immunologist. During the COVID-19 pandemic Clancy was involved in controversy when he was quoted by Australian MP Craig Kelly in support of unverified information about claimed benefits of the drugs hydroxychloroquine and ivermectin. Newcastle University issued a statement in which it distanced itself from Clancy’s views ... **the university did "not consider Robert Clancy a subject matter expert on COVID-19."**

Gigi Foster is a U.S. born academic and economist. She is currently a professor of economics at the University of New South Wales. Foster attracted criticism over her stance to Australia’s response to the COVID-19 pandemic. In particular, she criticised the COVID Zero-centred approach adopted by Victoria and other jurisdictions within Australia, believing that the costs to the economy outweighed the potential benefits of reducing case numbers. Her then-employer **the University of New South Wales distanced themselves from her comments** which were televised during the show Q&A.

Dr Melissa McCann is a Cosmetic Physician specialising in dermal fillers and anti-wrinkle injections and other non-surgical procedures. Dr McCann wrote to Professor Skerritt, then the TGA boss, calling for an immediate halt to the vaccination program, providing what she described as scientific evidence of serious harm caused by the vaccines. Professor Skerritt responded, denying her claims. In March this year, Dr McCann received a letter from the TGA’s chief medical advisor that raised concerns about her speeches at a vaccine conference and alleged **she was spreading misinformation**.

It was first tested in the 1990s, including in the contexts of Zika, rabies, and influenza vaccines, not just certain cancers and rare genetic disorders as alleged in the report.” **The TGA dismissed claims there were more reported injuries from the COVID-19 vaccines than for all other medicines and vaccines as false and unscientific.** “There is no credible evidence to suggest that COVID-19 vaccines cause heart attacks, strokes, cancer, infertility, or miscarriages,” the TGA said. “These conditions have not been linked to COVID-19 vaccination in Australia or internationally from data from the billions given internationally.” Deaths in children linked to COVID-19 vaccines was misinformation.

TGA: Full and thorough assessment

The TGA stated that it fully and thoroughly assessed the Cominarty (Pfizer), Spikevax (Moderna), Nuvaxovid (Novavax), and Vaxzevria (AstraZeneca) vaccines, and all are safe and effective at preventing severe illness, hospitalisation and death from COVID-19.

I find it interesting that Phillip and his associates keep talking about being censored, while at the same time holding symposiums at the Double Bay’s Golden Sheaf hotel and the University New South Wales ... in fact, anywhere they want. The quote from the medical professional of 40 years, commenting on one of Phillip’s talk, is from a function at the Royal Society, no less. Censorship?

Note: “Dr McCann received a letter from the TGA’s chief medical advisor that **raised concerns** about her speeches at a vaccine conference and alleged she was spreading misinformation.” Concerns are raised ... but nobody prevents them from speaking.

Open VAERS, from Wikipedia: <https://en.wikipedia.org/wiki/OpenVAERS>

OpenVAERS is an American anti-vaccine website created in 2021. The website misrepresents data from the Vaccine Adverse Event Reporting System (VAERS) to promote misinformation about COVID-19 vaccines. OpenVAERS misrepresents data from the VAERS database to indicate that the COVID-19 vaccines are harmful by publishing unverified data and statistics on the number of people who have allegedly died or suffered injuries after being vaccinated against COVID-19. The website is designed to present the information in an easily accessible format, which allows decontextualized screenshots to be shared on social media platforms such as Twitter, Facebook and TikTok (and on Phillip’s Substack). Logically noted that the website did not include the VAERS disclaimer for how its data should be interpreted. The British anti-disinformation organization reported that 30% of the website’s referral traffic came from *The Gateway Pundit*, a far-right fake news website, and over 10% came from English conspiracy theorist Vernon Coleman.

Note: *I myself don’t make any claims regarding CoViD or CoViD vaccines ... I know nothing of the science; all I’m doing is quoting medical authorities. For Phillip and his associates to claim they are all lying is preposterous ... the mother of all conspiracy theories.*
